



Alabama EAS Monitor Assignments

updated 1/28/26

All EAS Participants (AM, FM, TV, LPFM and LPTV) must install and deploy an EAS encoder (see 11.32) and an EAS decoder (see 11.33), certain exceptions apply to Class D non-commercial educational FM, LPFM, and LPTV stations, which are not required to install and deploy an EAS Encoder but may do so on a voluntary basis.

The decoder must be programmed to receive, at a minimum, two (2) local sources capable of receiving and relaying national level alerts/test. In addition, the decoder must monitor the IPAWS network via the internet connection.

This document lists the required local monitor sources for Alabama EAS zones. Each zone has 4 stations listed. Choose the two that you can receive clearly. If you cannot receive two of the sources accurately, contact the [Alabama SECC](#) for re-assignment.

The National Primary (NP) source for National level alerts in Alabama is WJOX-FM (94.5) Birmingham. We encourage all stations that are able to receive WJOX-FM reliably to add this source to your EAS unit.

Sirius XM (Channel One) and National Public Radio (Squawk Channel) serve as backup options for nationwide tests and alerts.
